Membership Enrollment Form - Independent Restaurant / Food court

Eligibility

Any person(s) actively engaged in the business of restaurant, catering and or any such food service as proprietors, firms or Company, shall be eligible to become an individual member.

A Food Court consisting of a number of outlets specializing in variety of cuisines and located at the same place as a single composite unit is also eligible to take Individual Membership.

CRITERIA FOR RESTAURANT MEMBERSHIP

1. Must have minimum 25 covers. The Restaurant must hold a license granted by the competent Government/ Local Authority to run a restaurant and must be open to general public.
2. There should be good quality crockery, cutlery, glassware, silverware, tableware & linen used.
3. Arrangements for hygienic washing of utensils, crockery, cutlery and glassware should be made. In case of manually operated washing system, three sink -unit should be installed.
4. There should be a clean, hygienic and well-maintained kitchen with proper and adequate cold storage facilities.
5. Adequate lighting in the kitchen area is essential
6. Water for cooking & drinking should be of acceptable quality. There should be suitable water filtration / Reverse Osmosis system installed.
7. The staff needs to be in clean uniform and should be properly groomed. There should be provision for adequate staff facilities like meals and locker rooms.
8. There should be adequate parking space.
