CRITERIA / CONDITIONS FOR CORPORATE / FOOD COURT MEMBERSHIP

1. Corporate having more than TEN outlets/Restaurants under the same brand all over India.
2. Corporate having franchisees from more than one brand of restaurants totalling more than ten units will also be eligible for Corporate Membership by clubbing the brands as one entity.
3. Food courts (each cluster of small outlets in the same place specializing in selected cuisines as a part of single composite food court owned by an individual restaurateur or by a firm or a partnership entity or a company) are also eligible for corporate membership.
4. Food court having multiple units and owned by different owners can also be considered for Corporate membership by clubbing the units located at different food courts, totalling 11 or more supported by trade/health license obtained by them.
